This is a Divisional Patent filed as a process patent, using the inventive step of a detachable liner. More particularly, the invention relates to a WSF system with actives embedded/entrapped therein such as to provide precise and desired release of actives there from and its method of manufacturing for diverse applications, in which a variety of substance such as (Pharma) active ingredients, detergents, softeners, perfumes, pesticides, fungicides, active agents for cleaning, laundry, dishes, etc., and like can be so embedded/entrapped for such purpose.

The Invention further discloses novel online and offline process for the manufacture of such multilayered WSF with or without liners and of desired shapes to selective entrap interacting/ non – interacting materials and their combinations. The process also provides options for the use of a wide range of raw materials, liners such as paper, film, foil, fabric, etc."

Arrow Greentech Limited is a pioneer in manufacturing Water Soluble Film by a unique method using detachable liners. Arrow's RND department discovered this unique method using their years of experience, to ensure that precise dosages of actives are embedded in the WSF and that the actives don't get "Burnt out" or degrade during the process of manufacture.
