IP Cell has informed, ‘The present invention relates in general to medicated bands/bandages and covering material, and in particular to processes for making medicated bands which allow application of one or more medication to be delivered to the wound. The medication and or active ingredients are stored in a soluble core reservoir within the medicated band itself.’

APPLICATIONS OF THE PATENT:

- Medicated bands /bandages in wide width rolls which can be carried in ambulances or first aid kits in a relatively small space.
- Medicated bands /bandages that can cover larger wounds while simultaneously delivering various medications as required /prescribed for the treatment.
- Medicated bands /bandages that can has various active ingredients as required /prescribed for different types wounds (eg. burns, incisions, punctures, abrasions, lacerations, bruises, etc.)
- Medicated bands /bandages to be used for treatment of complicated wounds.
- Medicated bands /bandages to be used for treating burn wounds especially injuries or wounds due to high degree of burns. Or for initial treatment of burn wounds to prevent infections.
- Medicated bands /bandages that help simplify the treatment process especially when multiple actives are required or when the wound area is not easy to treat.
- Medicated bands /bandages that can be sealed by moisture and pressure without degenerating the actives that are sensitive and /or can easily loose efficacy.
